PLAINTIFF'S NOTICE OF SUPPLEMENTAL AUTHORITY

In their Motions to Disqualify ("MTDQ"), Defendants State Farm and Renfroe focused substantially on alleged conduct committed by Richard Scruggs ("Scruggs") and the Rigsby Sisters that is the subject of litigation before the Northern District of Alabama. Defendants extensively cited the record from that litigation and discussed Judge Acker's request for a criminal contempt prosecution against Richard Scruggs as support for their MTDQs.

Notwithstanding Defendants' reliance upon allegations of contempt and the record developed before Judge Acker, the Northern District of Alabama has dismissed with prejudice the criminal contempt charges against Scruggs. Judge Vinson held: 1) that the Northern District of Alabama Court had no jurisdiction over Scruggs; and, 2) even if the Court had jurisdiction, the injunction prohibiting use of the Rigsby documents expressly excluded "law enforcement" and therefore, Mr. Scruggs did not violate the injunction when he gave the Rigsby documents to Attorney General Hood. Also, Judge Vinson held that the Rigsbys did not violate Judge Acker's injunction and thus, that, Scruggs did not "aid and abet" the Rigsbys in any such violation.
